SR-22 Filings

Available for named insured, spouse, or dependent child. All vehicles in the household must be insured on the policy. Only one SR22 will be issued per policy. Can be endorsed mid-term.

Non-Owner Policies – Not available

Discounts – Advanced Purchase, EFT Checking Pay Plan, Anti-Theft, Multi-Car, Pay in Full, In Agency Transfer, Transfer, Homeowners, Claim Free Renewal Discount (given at end of term if no claims reported) Retain proof in your file and provide upon request.

Vehicles

Unacceptable for Physical Damage

Vehicle(s) with **original MSRP greater than \$50,000** not eligible

Trucks/Vans – 1 Ton payload or less is acceptable

Vehicle Registration

Can not be registered to business or Corporation.

Business/Artisan Use- Not available

Uber/Lift (Rideshare), Any delivery, Taxis are unacceptable

Salvaged Vehicles – Liability Only coverage

Retain photos in your file for any vehicle that has Comp/Coll coverage. You must provide to Entegra if requested in event of a claim

No Coverage for Custom Equipment (Only Factory OEM Equipment is covered)

Additional/Replacement Vehicle

Insured must notify Entegra within 30 days of vehicle being acquired.
If policy is Liability only, no Physical Damage will be extended.

Rental Reimbursement
